## Terms & Conditions

Please read the terms and conditions below. You must accept the terms and conditions in order to finish the registration.

I hereby confirm that I am authorized to enroll the "Registered Organization" in the RecycleFund Program (further referred to as "The Program"). I agree, on behalf of the Registered Organization that participation in RecycleFund will be subject to the following terms and conditions.

1. Funding will be awarded by RecycleFund to the Registered Organization and credited to its account based upon the values established by RecycleFund for qualifying products (herein referred to as "Products." RecycleFund, in its sole discretion, will determine, at any point in time, which types of Products are qualifying and the monetary value awarded under the Program. RecycleFund does not pay for previously re-manufactured or "non-virgin" cartridges or any other cartridges or cell phones not listed on our price list. RecycleFund retains the right to deduct the expense of recycling items not listed on our price list from the participants account. RecycleFund may change, at any point in time and without prior notice to the Registered Organization, the values assigned to the various types of Products, the designation of which types of qualifying Products, and the monetary equivalent value of each item in the Program. Each month payments will be sent to all participants that have a balance in their account of \$40.00 or more.

2. The Registered Organization must designate a coordinator (the "Coordinator") in order to participate in The Program. RecycleFund shall be entitled to rely absolutely and conclusively on all transactions undertaken by means of the username and password of the Registered Organization's Coordinators and all such transactions shall be binding on the Registered Organization.

3. Product Values or Account Balances will not expire as long as the Registered Organization keeps its Program account active.

1. Recycling accounts will remain active when RecycleFund received not less than one (1) qualifying cartridge or cellular phone to RecycleFund in the latest 12-month period. If the Registered Organization does not send at least one qualifying Product to RecycleFund within any 12-month period. RecycleFund has the right to classify that organization as inactive, and further the right to deactivate the balance in the Registered Organization's account.

4. RecycleFund may specify additional provisions pertaining to the Program, including descriptions and details of the Program, throughout this website, and the Registered Organization shall be bound by all such additional provisions, descriptions and details; provided, however, that in the event that these Terms and Conditions of the Program conflict with any additional provisions, descriptions or details specified on this website, these Terms and Conditions of the Program shall govern.

5. RecycleFund may change these Terms and Conditions of the Program at any time without prior notice and the Registered Organization will be bound by all such changes as of the date they appear on this website.

6. Either party, without notice, may terminate this Agreement at any time for any reason.
